## **Osha Requirements For Warehouse Racking**

The truth is, when it comes to warehouse racking safety guidelines, OSHA doesn't offer much guidance. There are only two applicable rules: 1910.176(b) , which effectively states that material stored in tiers must be made safe, and 1910.159 , which covers fire sprinklers and essentially requires 18 inches of clearance between the rack and the sprinkler.

## **Warehouse Racking Safety Guidelines: Satisfying OSHA ...**

OSHA Requirements for Warehouse Pallet Storage Safety 176 (a): "Where mechanical handling equipment is used, sufficient safe clearances shall be allowed for aisles, at loading docks, through doorways and wherever turns or passage must be made.

All materials stored in tiers shall be stacked, racked, blocked, interlocked, or otherwise secured to prevent sliding, falling or collapse. 1926.250 (a) (2) (i)  
The weight of stored materials on floors within buildings and structures shall not exceed maximum safe load limits.  
1926.250 (a) (2) (ii)

## **1926.250 - General requirements for storage ...**

The inspections should be performed by a qualified person familiar with the storage rack design and installation requirements retained or employed by the storage rack system owner. OSHA defines a qualified person in 29 CFR 1910.21(b): a person who, by possession of a recognized degree, certificate, or professional standing, or who by extensive knowledge, training, and experience has successfully demonstrated the ability to solve or resolve problems relating to the subject matter, the work ...
